Author of "The ICTR's Contribution to National Reconciliation," *Journal of International Criminal Justice* (August 12, 2005), September 2005, 3.4: 944-949.



Lars Waldorf, Senior Lecturer, Centre for Applied Human Rights, York Law School, University of York, United Kingdom. Administered Human Rights Watch field office in Kigali, Rwanda, 2002-2003. Co-edited and co-authored *Remaking Rwanda: State Building and Human Rights after Mass Violence* (Univ. of Wisconsin Press, 2011); co-edited *Localizing Transitional Justice: Interventions and Priorities after Mass Violence* (Stanford Studies in Human Rights, 2010) and *Disarming the Past: Transitional Justice and Ex-Combatants* (Social Science Research Council, 2010). He is writing a book on Rwanda's community genocide trials (*gacaca*).



Nicole Fox, PhD candidate, Department of Sociology, Brandeis University and newly appointed Assistant Professor, Department of Sociology, University of New Hampshire. Her dissertation is titled "Moving Beyond Violence: Memory and Nation in Post-Genocide Rwanda." Her scholarship on Rwanda has been published in the *Journal for Scientific Study of Religion, Societies Without Borders*, and the *International Journal of Sociology of the Family*.

Press of America, 2003); Hutu and Tutsi (Rosen Publishing Group, 1997).



Jean-Paul Kimonyo, Senior Policy Advisor to the President of the Republic of Rwanda, Kigali, 2009-present. He holds a PhD in Political Science and Government from The University of Quebec in Montreal, 2002. He is author of *Rwanda: Un Genocide Populaire* (Karthala, 2008), and is currently working on a book on Rwanda's Reconstruction (1994-2014) in comparative perspective.



Noel Twagiramungu, former head, League of Human Rights in the Great Lakes of Africa and the Rwandan League for the Promotion and Defense of Human Rights. He holds an LLM degree from Utrecht University and was Scholar at Risk at Harvard University in 2005-2006. He has taught at the University of Dar es Salaam and Smith College, and is co-author of *Un Homme Libre au Rwanda* (Karthala, 2004). He is currently a PhD candidate in The Fletcher School of Law and Diplomacy, Tufts University. His dissertation is titled, "Two Rebel Roads to Power: Explaining Variation in the Transition from Genocidal

Violence to Rebel Governance in Contemporary Rwanda and Burundi." He is also writing a *Historical Dictionary of Burundi* (Scarecrow Press, forthcoming).
